Regular Meeting: After due and legal notice, the Regular Board meeting of the Columbia River Fire & Rescue Board of Directors was called to order by President Niles at 7:00 pm.

Flag Salute: President Niles led the flag salute.

Changes to agenda: VP Welby made a motion to amend the agenda. Director Zimbrick 2nd the motion. VP Welby made a motion to terminate Chief Joel Medina, VP Welby read a statement/resolution regarding the termination. There was discussion and disagreement from Director Hudson regarding the termination of Chief Medina. Director Hudson requested VP Welby define "for cause" surrounding the termination, but none was provided. VP Welby went on to state that what he's heard and read was reason enough. Zimbrick made a statement that he felt in his heart it was the right thing to do and you could see it on the faces of the firefighters. Secretary Fletcher stated he supported the decision that the department is the worst it has ever been. Director Hudson reminded Welby, Zimbrick, and Fletcher of the closed executive session at the last board meeting and that they were opening themselves up to be personally liable for the lawsuit that would undoubtedly accompany their decisions. Director Hudson stated that they were bought and paid for and had been planning this ahead of the meeting. Director Hudson discussed that allegations against the Fire Chief do not constitute for cause reasoning. He asked to see proof of their findings relating to the termination of Chief Medina and said that they should have further discussion when they could provide supporting evidence for cause. President Niles concurred with Director Hudson and discussed putting Chief Medina on administrative leave to offset liability. President Niles reiterated that there would be consequences for their actions. President Niles all in favor of amending the agenda, 4-1 Director Hudson nay. VP Welby motion for resolution FY 23-24-02 For Cause Termination of Chief Joel Medina, Director Zimbrick 2nd the motion, 3 in favor, Director Hudson nay, President Niles abstained. Chief Medina asked President Niles why he abstained, President Niles stated he thought Chief Medina should be placed on leave and not terminated. Chief Medina requested the resolution be read out loud in its entirety. President Niles read the resolution for the termination of Chief Medina.

VP Welby made a request for a 2nd agenda amendment. VP Welby made a motion to amend the agenda to add resolution FY 24-23-03, Appointing Chief Gorsuch as the interim Fire Chief. Director Zimbrick 2nd the motion, 4-1 Director Hudson nay. VP Welby read the resolution out loud and made a motion to accept resolution FY 24-23-03, Director Zimbrick 2nd the motion. Director Hudson discussed that the resolutions were prepared in advance by an outside party, and the three new board members had been preparing for this action prior to the board meeting. VP Welby confirmed that an outside party composed the resolutions. Director Hudson asked if the three new board members were in agreement with placing Chief Gorsuch in the interim position. Director Zimbrick commented that he thought Chief Gorsuch would be a good fit. Director Hudson stated that the situation looked like collusion, and it was another nail for the district and the 3 new board members. Director Hudson said he wanted to see someone in the leadership role for the time being but that it would be incredibly hard to fill the seat with the tarnished reputation and stink the district has. All in favor 5-0, Motion carries.

The presentation by Jeff Griffin regarding board member duties and responsibilities was canceled. Mr. Griffin stated that he could present another time.

One of the tenets that he managed by was to praise in public and coach in private. Accusations that you make about coaching and counseling are without merit.
